**Job Summary/Job Purpose:**

The Welsh Clinical Leadership Training Fellowship (WCLTF) programme is a one-year opportunity for dentists, pharmacists, optometrists, and Allied Health Professionals. The WCLTF programme provides training and hands-on experience in clinical leadership and management.

The role offers a significant opportunity to help shape national and regional initiatives. You will be working directly to a senior lead, collaborating with teams across NHS Wales and engaging with a wide variety of partners and stakeholders. The post provides a significant career development opportunity to build networks, acquire a deep system appreciation whilst supporting the delivery of key programmes of work. The role supports the business in driving transformation as well as value for money in planning, commissioning and service, and is designed to build a combination of subject matter expertise and technical skills to develop a strong service delivery.

The Training Fellow will be seconded (please ensure the applicant has the permission of their substantive employer to undertake this secondment) or be eligible for an out of programme (OOP), if a medical/dental trainee, for a period of 12 months to the host organisation/department within NHS Wales in which their project is based.

The aim of the scheme is to recruit and develop the most aspiring clinical leaders of the future. As part of the programme, you will undertake a leadership and management project from proposals submitted by healthcare organisations in Wales. Leadership Fellows work closely with senior medical, dental, pharmacy or optometry colleagues and are supported in their host organisations by project supervisors.

There is an academic element of the programme provided by Glyndwr University, and masterclasses throughout the year with the Faculty of Medical Leadership and Management. The programme equips the Leadership Fellows with a range of knowledge, skills and experience required to be credible and influential clinical leaders in a future modern NHS.

**Eligibility and Selection Criteria:**

The scheme is open to the following professional groups that meet the essential eligibility requirements: pharmacists, optometrists, healthcare scientists and allied health professionals. Applicants must be able to meet the following eligibility criteria at the time of application.

- Applicants should be working at A4C Band 7 level or ST3 or above (medical trainees, except for GP trainees), GPST2 or above (GP trainees), DCT2 or above (dental trainees) at the point of application, and if successful, at the point of entering the fellowship scheme.
- Medical and dental trainees must be eligible for an out of programme (OOP), as defined in the Gold Guide.
- Applications from those wishing to work on a Less than Full Time (LTFT) basis are welcomed.
- Demonstrable skills in both written and spoken English to enable excellent and effective communication.
- Able to travel across various sites where applicable.

## **DUTIES/RESPONSIBILITIES:**

### **Communication:**

- Develop and maintain effective communication and productive working relationships with internal and external stakeholders to ensure effective cross-functional and team working. This will include the Project Supervisor, senior staff from NHS Wales, Welsh Government, industry and academic staff.
- Orally present findings on aspects of your project and internal and external meetings. These will include assessment group meetings, local and national meetings and conferences. These meetings may be attended by a range of individuals including senior NHS professionals, academics and lay individuals.
- Have the ability to answer questions effectively.
- Provide information in a range of written formats. This may include preparation of data collection tools, formal reports, presentations, information suitable for patients and the public to understand, and scientific papers for publication in peer-reviewed scientific journals.
- Internal communication with staff at all levels from throughout NHS Wales, particularly those with associated work programmes.
- External communications including face-to-face, telephone and/or email communication to seek information, advice, data and other forms of evidence from many stakeholders.
- Engage with a range of stakeholders subject to the requirement of the project workstream producing high quality project materials, correspondence and papers supporting effective communication and stakeholder management, both internally and externally.

### **Finance and Budget**

- Responsible for ensuring adherence to the budget, ongoing monitoring of expenditure against budget and ensuring the appropriate documentation is available for scrutiny.
- To ensure the effective use of all resources and to ensure that any agreed budgets are kept within specified financial limits and operate within approved financial policies.

- Fellows will be supported in their leadership learning by a blended education programme with Glyndwr University, designed to cover a wide range of critical development themes.
- Masterclasses and workshops are held throughout the year with the Faculty of Medical Leadership and Management.

**Effort and Environmental**

- Post entails a range of tasks which would include standing, walking, sitting, and desk-based work,
- To concentrate for prolonged periods in the checking of key documents, interpreting and analysing statistics and data, managing priorities and providing a quality assurance function and developing high level and complex reports. Participate in and facilitate meetings which require a high level of concentration on a wide range of topics, with a variety of audiences and mixtures of attendees. Prolonged periods of intense concentration, with the ability to manage competing demands.
- Influence and persuade individuals and audiences where there may be challenges in terms of opposing opinions.
- Present material and respond to challenges and scrutiny of the information provided.
- Use of VDU more or less continuously.

## PERSON SPECIFICATION:

The knowledge to be measured is the minimum needed to carry out the full duties of the job to the required standards. Qualifications should be used to provide an indicator of the level of knowledge required. Training and experience is also a means of acquiring the knowledge required for a job such as on-the-job training, short courses and experience to an equivalent level of knowledge which should be specified.

## **GENERAL REQUIREMENTS**

Include those relevant to the post requirements

- **Values:** All employees of the Health Board are required to demonstrate and embed the Values and Behaviour Statements in order for them to become an integral part of the post holder's working life and to embed the principles into the culture of the organisation.
- **Registered Health Professional:** All employees who are required to register with a professional body, to enable them to practice within their profession, are required to comply with their code of conduct and requirements of their professional registration.
- **Healthcare Support Workers:** Healthcare Support Workers make a valuable and important contribution to the delivery of high quality healthcare. The national Code of Conduct for NHS Wales describes the standards of conduct, behaviour and attitude required of all Healthcare Support Workers employed within NHS Wales. Health Care Support Workers are responsible, and have a duty of care, to ensure their conduct does not fall below the standards detailed in the Code and that no act or omission on their part harms the safety and wellbeing of service users and the public, whilst in their care.
- **Competence:** At no time should the post holder work outside their defined level of competence. If there are concerns regarding this, the post holder should immediately discuss them with their Manager/Supervisor. Employees have a responsibility to inform their Manager/Supervisor if they doubt their own competence to perform a duty.
- **Learning and Development:** All staff must undertake induction/orientation programmes at Corporate and Departmental level and must ensure that any statutory/mandatory training requirements are current and up to date. Where considered appropriate, staff are required to demonstrate evidence of continuing professional development.
- **Performance Appraisal:** We are committed to developing our staff and you are responsible for participating in an Annual Performance Development Review of the post.
- **Health & Safety:** All employees of the organisation have a statutory duty of care for their own personal safety and that of others who may be affected by their acts or omissions. The post holder is required to co-operate with management to enable the organisation to meet its own legal duties and to report any hazardous situations or defective equipment. The post holder must adhere to the organisation's Risk Management, Health and Safety and associate policies.
- **Risk Management:** It is a standard element of the role and responsibility of all staff of the organisation that they fulfil a proactive role towards the management of risk in all of their actions. This entails the risk assessment of all situations, the taking of appropriate actions and reporting of all incidents, near misses and hazards.
- **Welsh Language:** All employees must perform their duties in strict compliance with the requirements of their organization's Welsh Language Scheme and take every opportunity to promote the Welsh language in their dealings with the public.



- **Information Governance:** The post holder must at all times be aware of the importance of maintaining confidentiality and security of information gained during the course of their duties. This will in many cases include access to personal information relating to service users.
- **Data Protection:** The post holder must treat all information, whether corporate, staff or patient information, in a discreet and confidential manner in accordance with the provisions of the General Data Protection Legislation and Organisational Policy. Any breach of such confidentiality is considered a serious disciplinary offence, which is liable to dismissal and / or prosecution under current statutory legislation and the HB or Trust Disciplinary Policy.
- **Records Management:** As an employee of this organisation, the post holder is legally responsible for all records that they gather, create or use as part of their work within the organisation (including patient health, staff health or injury, financial, personal and administrative), whether paper based or on computer. All such records are considered public records and the post holder has a legal duty of confidence to service users (even after an employee has left the organisation). The post holder should consult their manager if they have any doubt as to the correct management of records with which they work.
- **Equality and Human Rights:** The Public Sector Equality Duty in Wales places a positive duty on the HB/Trust to promote equality for people with protected characteristics, both as an employer and as a provider of public services. There are nine protected characteristics: age; disability; gender reassignment; marriage and civil partnership; pregnancy and maternity; race; religion or belief; sex and sexual orientation. The HB/Trust is committed to ensuring that no job applicant or employee receives less favourable treatment of any of the above grounds. To this end, the organisation has an Equality Policy and it is for each employee to contribute to its success.
- **Dignity at Work:** The organisation condemns all forms of bullying and harassment and is actively seeking to promote a workplace where employees are treated fairly and with dignity and respect. All staff are requested to report any form of bullying and harassment to their Line Manager or to any Director of the organisation. Any inappropriate behaviour inside the workplace will not be tolerated and will be treated as a serious matter under the HB/Trust Disciplinary Policy.
- **DBS Disclosure Check:** In this role you will have \* direct / indirect contact with\* patients/service users/ children/vulnerable adults in the course of your normal duties. You will therefore be required to apply for a Criminal Record Bureau \*Standard / Enhance Disclosure Check as part of the HB/Trust's pre-employment check procedure. \*Delete as appropriate. If the post holder does not require a DBS Disclosure Check, delete as appropriate.
- **Safeguarding Children and Adults at Risk:** The organisation is committed to safeguarding children and adults at risk. All staff must therefore attend Safeguarding Children & Adult training and be aware of their responsibilities under the All Wales Procedures.
- **Infection Control:** The organisation is committed to meet its obligations to minimise infections. All staff are responsible for protecting and safeguarding patients, service users, visitors and employees against the risk of acquiring healthcare associated infections. This responsibility includes being aware of the content of and consistently observing Health Board/Trust Infection Prevention & Control Policies and Procedures.
- **No Smoking:** To give all patients, visitors and staff the best chance to be healthy, all Health Board/Trust sites, including buildings and grounds, are smoke free.
